MAIN CHALLENGE OF THE 2021 PRE-FORUM	Address the topic of food sustainability from different perspectives actively involving EC agencies, researchers, food safety authorities, consumers' representatives, industries and all the stakeholders of the value chain.
COLLABORATION	The event will host representatives from EFSA, JRC, DG Research & Innovation Bioeconomy and Food Systems (RTD.B2), policy officers as speakers and observers, and all the interested stakeholders of the food safety system.
