

Technical assistance to support discussions on national risk management measures to address possible shortages of food and feed supply as a consequence of the Russian invasion of Ukraine

Some EU Member States depend to a great extent on feed imports from Ukraine. Following the Russian invasion of Ukraine, the supply chains are interrupted, and stakeholders informed the European Commission about possible imminent shortages, mainly for wheat, barley, maize, sunflower seeds, rapeseeds and soyabeans used for feed purposes. As a consequence, they announced to take steps to find alternative sources for importing these products.

"Shifting Urban Diets: Operationalizing Food System Targets for Health and Sustainability" worked with the City of Copenhagen and partners to translate the findings of the EAT-Lancet Commission on Food, Planet, Health into local action. The three-year project (2019-2021), co-funded by EIT Climate-KIC, helped demonstrate how scientific targets for food systems can be implemented at a city scale, with Copenhagen as a prototype and other cities consulted throughout.
