EU-FORA – The European Food Risk Assessment Fellowship Programme

The European Food Risk Assessment (EU-FORA) Fellowship Programme is a key initiative for ensuring preparedness for future risk analysis needs. The programme keeps evolving based on six years of experience, the implementation of 94 work programmes, and the participation of more than 70 supervisors from 40 organisations in 16 different EU Member States and the UK.

The programme aims to increase the pool of food safety risk assessment experts available in Europe and stimulate the involvement of Member States in risk assessment work, all with the ultimate objective of building a common EU culture for risk assessment.

Expert Survey on the derivation of conversion factors for new sources and forms of nutrients

EFSA is holding an open consultation through an Expert Survey on the derivation of conversion factors for new sources of nutrients.

The European Commission requested that EFSA update its "Guidance on safety evaluation of sources of nutrients and bioavailability of nutrient from the sources" regarding the scientific principles and data requirements for applicants. The update will support the derivation of conversion factors for proposed new sources or forms of nutrients to be authorised for addition to foods, including food supplements.

Stakeholders and scientific experts are invited to submit scientific input via an online Survey until 20 January 2023.









Announcement "Increasing health equity through promoting healthy diets and physical activity"

The Partnership "Fostering a European Research Area for Health" (ERA4Health) aims at establishing a flexible and effective coordination between funding organisations in the European Research Area (ERA) for Health and Well-being.



The ERA4Health call for transnational research proposals "Increasing health equity through promoting healthy diets and physical activity (HealthEquity)" has been opened on 13 January 2023. The aim of this call is to develop novel strategies and targeted approaches to identify, understand, and modify determinants and mechanisms of diet-related behaviour and physical activity as well as sedentary behaviour, which have the potential to break through the cycles maintaining unhealthy behaviours and lifestyles and to reduce health inequalities.

Healthy Food Design - VLAG Course | I-5 May 2023


